TRAIL RIDER'S RELEASE OF LIABILITY AND INDEMNITY AGREEMENT
EXHIBIT "A" TO RULES AND REGULATIONS

I understand that being around horses is inherently dangerous because they are living creatures and are not predictable.

In consideration for being allowed entry into and participation in activities (the "Activities") associated with (i) the Houston Livestock Show and Rodeo, Inc., the Houston Livestock Show and Rodeo Educational Fund, the Rodeo Institute for Teacher Excellence, the Houston Livestock Show and Rodeo Endowment Foundation, and the Corral Club, Inc. (collectively, "HLSR") and the (ii) **SALT GRASS TRAIL RIDE ASSOCIATION** (the "Trail Ride"), the undersigned hereby releases and discharges HLSR and the Trail Ride; their insurance carriers; their legal representatives; their present and former corporate parents, subsidiaries, affiliates, predecessors, and successors; their present and former directors, officers, employees, agents, and representatives, and the respective heirs, administrators, executors, successors, and assigns of any of the foregoing (collectively, the "HLSR and Trail Ride Parties") from any and all claims, causes of action, suits, or demands for personal injury, death or property damage, accrued or to accrue in the future, known or unknown, relating to or arising out of any negligent, grossly negligent and/or intentional acts on the part of the (i) HLSR and Trail Ride Parties and/or the (ii) undersigned in connection with the undersigned's entry into and participation in the Activities. **The undersigned further agrees, on behalf of himself/herself and on behalf of any and all of his/her heirs, successors and assigns, to DEFEND, INDEMNIFY and HOLD HARMLESS the HLSR and Trail Ride Parties from and against all claims, all costs, expenses and legal fees incurred in defending the same, made by, through or against the undersigned, or on his/her behalf, relating to or arising out of any negligent, grossly negligent and/or intentional acts on the part of (i) the HLSR and Trail Ride Parties and/or (ii) the undersigned in connection with the undersigned's entry into and participation in the Activities.** I further agree to venue in Harris County, Texas, for all purposes. The undersigned warrants that he/she has read this AGREEMENT and fully understands it to be a release of all claims, known or unknown, present or future, that he/she has or may have against HLSR and the Trail Ride Parties.

The undersigned GRANTS PERMISSION to be PHOTOGRAPHED or INTERVIEWED in connection with the Activities. The undersigned understands that any such photograph or interview may be used by HLSR and Trail Ride Parties for television, film, video, visual, graphic or printed media. The undersigned agrees to RELEASE and INDEMNIFY the HLSR and Trail Ride Parties with respect to any Claims related to the usage of such photographs or interviews by the HLSR and Trail Ride or any media.

I FURTHER CERTIFY THAT I HAVE NEVER BEEN CONVICTED OR RECEIVED DEFERRED ADJUDICATION AS A SEX OFFENDER OR OF ANY CRIME RELATED TO ABUSE, ASSAULT OR VIOLENCE TOWARD A CHILD. I AUTHORIZE HLSR TO REVIEW ANY SEX OFFENDER REGISTRIES UNDER MY NAME. I AGREE THAT IF I AM CHARGED WITH SUCH A CRIME, THAT I WILL IMMEDIATELY ADVISE THE PRESIDENT OF HLSR. I ALSO AGREE TO ABIDE BY ALL HLSR RULES AND POLICIES.

UNDER TEXAS LAW (CHAPTER 87, CIVIL PRACTICE AND REMEDIES CODE) AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.

I HAVE READ THIS RELEASE OF LIABILITY AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
